The Government of Tamil Nadu have in the reference fourth cited issued an orders extending complete lockdown from 12.07.2021 to 6.00 A.M. on 19.07.2021 in order to prevent the spread of COVID 19.

In the reference first cited Government of Tamilnadu issued an orders extending complete lockdown from 07.06.2021 to 6.00 A.M. on 14.06.2021 in order to prevent the spread of COVID 19 and also directed that Government Offices dealing with essential services and their associated support services shall function with required staff.

In the reference second cited Government of Tamilnadu issued an orders extending complete lockdown from 05.07.2021 to 6.00 A.M. on 12.07.2021 in order to prevent the spread of COVID 19 and also issued certain direction along with existing restrictions, SRF/JRF, M.Phil, Phd. Students shall be permitted to pursue their education related projects in respective Colleges and Universities, Colleges and Universities shall function for the above mentioned purpose.

Hence, the Deans of the Campuses/Directors/Head of the Departments/Unit Officers, Dean i/c of Regional Campuses and Constituent Colleges and the Principals of Affiliated Autonomous and Affiliated Non-Autonomous colleges of Anna University are requested to kindly adhere to the aforesaid Government directions scrupulously by following the Standard Operating Procedures for preventive measures of COVID-19, until further orders.

All the faculty members and teaching fellows are requested to be available for any clarification or to attend any urgent work related to the University, if required and the online courses/tutorials for students will be continued as usual during the aforesaid period.
